M8 BOLT = 20Nm


M10 BOLT = 40Nm

M12 BOLT = 40Nm





Carefully remove the inner panel/OEM radiator shroud (seen in <u>Picture 2</u>), refer to owner's manual
if necessary.

LHS & RHS Fairings can also be removed for ease of access if required

- Push the 6 x rubber grommets (ITEM 2) into the 6 x holes (Marked Red in <u>Picture 1</u>) in to the radiator guard making sure the pointed ends of the grommets are facing OUTWARDS as shown in <u>FITTING DIAGRAM</u> above (towards the front wheel when the guard is installed)
- Secure the corners of the radiator guard by threading a cable tie (ITEM 3) through the radiator guard's securing slots, seen in <u>Picture 1</u> (green) then through the gaps in each corner of the radiator.
- Snip the excess from the cable tie.
- Once the radiator guard is secure, re-attach the OEM shroud.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
